## Tournament of Sniff Champions

The Tournament of Sniff Champions is a fun event designed to provide an opportunity for teams to test their skills and work towards training goals. Teams may choose how they enter to best suit the needs and goals of their team. For example, a team may choose to only enter Scent Work to focus on developing those skills while another team may enter multiple levels of Lost Item Recovery and Urban Locating to work towards titles in those areas. Enter everything or enter one division. How you enter is up to you! Awards are offered by division and overall versatility each week and over the three weeks. **Teams may compete as FEO in the NASDA trials.** This is an excellent opportunity to train and work with your dog at higher levels or in classes where resets are not available for a second dog.

### Classes Offered

Not all classes are offered each day. Please see entry form for availability. Teams may compete as FEO in classes they are not eligible for. Only classes teams are eligible for will be submitted to NASDA.

**Urban Locating:** PAT, Level I, Level II, Level III, GCH

**Urban Challenge:** Games 1, 2, 3, 4, 5, 6

**Lost Item Recovery:** PAT, Level I, Level II, Level III, Master Champion

**Lost Item Challenge:** Games 1, 2, 3, 4, 5, 6

### Specialty Odor:

- Day 1: Cash
- Day 2: Electronics (Remote, Cell Phone or SD Card)
- Day 3: Novel Odor (Bed Bugs)

### Scent Work (Birch, Anise and / or Clove):

- Day 1: Two hides + AKC type distraction in each search area. Each element will consist of one search area. Odor: Birch, Anise and / or Clove
- Day 2: Two hides + NACSW type distraction in each search area. Each element will consist of one search area.
- Day 3:
  - Interiors: Two areas per trial with a total of 0 – 3 hides. Handlers must call finish in the first area before moving to the next. Once finish is called, the handler may not go back. Handlers may request to know the number of hides.
  - Exterior: One area per trial. Large, complex search areas with 0 – 5 hides. Handlers may request to know the number of hides.

**NASDA Trial results are scored separately from the tournament and submitted to NASDA for points towards eligible titles, similar to our NASDA Urban League.**

# Tournament of Sniff Champions

## Competition Divisions:

1. Urban Locating
2. Urban Challenge
3. Lost Item Recovery
4. Lost Item Challenge
5. Specialty Odor
6. Scent Work

## Tournament Scoring:

- Qualifying Score: Base points for each run less judge deductions
- First through Fourth in each class: +1 point
- Non-Qualifying Score: 1 point
- *Specialty Odor and Scent Work will be scored as NASDA sports for this event.*

## Weekly Awards:

- Most Versatile Dog
- High Scoring Dog in Each Division

## Overall Awards:

- Versatility Champion (Gold, Bronze, Silver)
- High Combined in Each Division (Gold, Bronze, Silver)

Most Versatile Dog is calculated by the greatest number of points across the largest number of divisions.

High Scoring Dog goes to the dog with the largest number of points in a specific division.

High Combined goes to the dog with the greatest number of points in a single division across all three weeks. Dogs do not have to compete in all three weeks to be eligible.

Versatility Champion goes to the dog with the greatest number of points in the largest number of divisions across all three weeks. Dogs do not have to compete in all three weeks to be eligible.

Prizes:

- First place: 3% of entry fees + goodies
- Second place: 2% of entry fees + goodies
- Third place: 1% of entry fees + goodies

Ties will be broken in a head-to-head run off in that division.

Applies to Urban Locating, Urban Challenge, Lost Item Recovery, Lost Item Challenge and Novel Odor (Test)

## Dog Registration:

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee. You may register your dog online at <http://nasda.dog/registration/>.

## Awards:

Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying score, Best of Breed and High in Class. New title ribbons will be awarded.

## Venue:

Exhibitors will be crating in their vehicles. **Revolution Dog Sports** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

## Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
