### **League Scoring**

League standings are based on each dog's total points earned over the six-week league session. To encourage training and skill development, dogs may participate For Exhibition Only (FEO) in levels for which they are not yet eligible to compete under the NASDA Rules (for example, a dog currently eligible for UL-I may participate FEO in UL-III).

Runs completed FEO will be included in the dog's League point total for league standings. However, pursuant to the NASDA Rules, FEO runs do not count toward titles, qualifications, placements, or other official NASDA awards until the dog is eligible to compete in that class.

This provides an outstanding opportunity for teams to challenge themselves, gain experience at higher levels, and prepare for future competition while continuing to participate in league scoring.

### **Handler Participation**

Handlers may compete with any number of dogs in accordance with the NASDA Rules. During league play, handlers may run all of their entered dogs except in classes requiring blind hide placement, where standard NASDA judging and handling restrictions remain in effect.

### **NASDA Trials**

#### **Dog Registration:**

Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee. You may register your dog online at <http://nasda.dog/registration/>.

#### **NASDA Rules:**

#### **Awards:**

Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying score, Best of Breed and High in Class. A special gift is given for new titles. New title ribbons will be awarded for Master Champion and Grand Champion.

#### **Venue:**

Exhibitors will be crating in their vehicles. Revolution Dog Sports reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog.

#### **Notice to Exhibitors:**

- Refunds will be mailed 7 days after the event.
- No refund for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to Liz Carter.
- Revolution Dog Sports reserves the right to refuse any entry without cause or explanation.
